#### **GENERAL INFORMATION**

**GENERAL:** Electrical work shall NOT be started until the Electrical Permit has been issued by the Grosse Pointe Woods Bldg. Dept. All installations shall be in conformance with the State Electrical Code. No work shall be concealed until it has been inspected.

**INSPECTIONS:** Contact the office to schedule all inspections. Inspections scheduled before 4pm will be scheduled for the following business day unless otherwise noted.

**PERMIT RENEWAL:** All permits shall be valid for 180 days. However, an extension may be requested by the original permit holder in writing. If permit is NOT expired, 1<sup>st</sup> extension is included in permit fee. IF another extension is needed, there will be an extension fee charged to extend if granted.

**EXPIRATION OF PERMIT:** A permit remains valid as long as work is progressing & inspection are requested & conducted. A permit shall become invalid if the authorized work is not commenced within 6 months after issuance of the permit or if the authorized work is suspended or abandoned for a period of 6 months after the time of commencing the work. A permit will be canceled when no inspections are requested & conducted within 6 months of the date of issuance or the date of previous inspection. Canceled permits cannot be refunded or reinstated.

**RE-INSPECTIONS:** If any inspection is not ready when the inspector arrives or the inspector is unable to enter the site, a **re-inspection fee will be charged.**
