DUTIES/RESPONSIBILITIES OF GROSSE POINTE WOODS CITY ATTORNEY

- 1. Charter Sec. 4.12 outlines the various functions and duties as follows:
 - (a) Act as legal advisor for the Council and be solely responsible to the Council. Advise any officer or department head relating to matters.
 - (b) Prosecute all ordinance violations.
 - (c) Prepare all ordinances, contracts, and other written instruments.
 - (d) Call to the attention of Council all matters of law and changes or developments affecting the City.
 - (e) Perform such other duties as may be prescribed by Charter or the Council.
- 2. As Prosecuting Attorney, attend all municipal court hearings and address civil infractions and misdemeanors as necessary. Review all misdemeanor warrant authorizations. Under present procedures, after a warrant is authorized, the Public Safety Department prepares a complaint and files it with the Court for arraignment purposes.
- 3. Attend all Council meetings including Committee of the Whole meetings. Prepare cover letters for specific agenda items as requested by Administration or Council or as necessary in conjunction with the City Attorney's duties.
- 4. Review all contracts approved by Council and approve for signature.
- 5. Review and provide general advice to department heads on issues as requested by the City Administrator, Appointed Officials or department heads.
- 6. The City Attorney is a member of the Election Commission and attends all Election Commission meetings and advises the Commission on general matters.
- 7. The City attorney represents and attends the Pension Retirement System and Retiree Health Care meetings and advises the City on general matters. Both Boards are represented also by attorney Michael VanOverbeke.
- 8. Occasionally attend Planning Commission meetings (last Tuesday of each month), especially when public hearings or major zoning/development projects are involved as is requested by the Planning Commission Chair.
- 9. Defend and litigate other Court cases as directed by Council involving general litigation, zoning matters, equitable actions, FOIA litigation, etc. (But see list of litigation not handled by City Attorney below.)
- 10. Oversee Tax Tribunal litigation. At present, a majority of the Tax Tribunal cases are handled by the City Attorney with the assistance of WCA Assessing, pursuant to a written contract. Major Tax Tribunal litigation (for example DRSN Real Estate v. Grosse Pointe Woods. "The Rivers") is currently being handled by Hallahan & Associates, P.C.

- 11. General Insurance Matters: The City Attorney works with the City's general liability insurance carrier along with Administration to determine whether claims should be submitted under the City's policy. The City in conjunction with the policy utilizes the services of McGraw Morris in defense of those claims. In addition, twice a year the City Attorney provides the City Council with a written summary of all pending claims and litigation. Tax Tribunal cases are summarized in a spreadsheet prepared by the City Comptroller and attached to the general summary letter.
- 12. Matters <u>not</u> handled by the City Attorney:
 - (a) All bond matters and advice. Generally handled now by Pat McGow at Miller Canfield.
 - (b) Insurance defense as previously mentioned above, currently handled by Tom McGraw, Gus Morris, and Stacy Belisle.
 - (c) Union employment matters all Union matters are handled by Keller Toma, Thomas Fleury. Mr. Fleury also assists the City and City Attorney with non-union employment matters from time to time. The City Attorney assists Administration and Council with general employee matters and matters relating to appointed officials. A comprehensive Employee Handbook exists and is being reviewed/revised by Mr. Fleury with input from the City Attorney.

PROPOSAL FOR LEGAL SERVICES

Timothy A. Dinan and Joel A. - 5. Perform other such duties as prescribed by the City Council.

B. Prosecuting Attorney Duties

- 1. Attend all Grosse Pointe Woods Municipal Court hearings;
- 2. Address civil infractions and misdemeanors to effectuate enforcement and the ends of justice;
- 3. Review all misdemeanor warrant authorizations; and
- 4. Annually review warrants, prosecutions and convictions for efficacy if requested by City Council.

C. Duties Relating to Functions of the Council and City Officials

- 1. Attend all City Council meetings;
- 2. Attend all Committee of the Whole meetings;
- 3. Prepare cover letters/legal memoranda for specific agenda items as requested by City Council or as necessitated by City Attorney duties;
- 4. Attend all Election Commission meeting as a member of the Commission and advise the commission on general legal matters;
- 5. Review all contracts approved by City Council and advise as to their import and affect if signed. Woods Counsel will advise regarding any concerns any agreement may pose;

- 6. Provide general legal counsel to City Department heads as requested by the City Administrator, Appointed Officials and department heads;
- 7. Advise the City Administration working in conjunction with the City's insurance defense counsel regarding the efficacy of submission of claims on the City's policy of insurance. We will provide a semi-annual report with summary of all open claims and litigation; and
- 8. Work with the City Comptroller to provide a listing of Tax Tribunal cases to the City Council with a summary letter regarding the status of these matters.

We will seek efficiencies in providing City Council with legal services and make suggestions on attorney utilization practices to save time, effort, and legal fees for City Council and the City.

Timothy Dinan shall serve as the primary contact to the City Council. Mr. Harris and Mr. Dinan will serve as back up counsel for each other to ensure continuity of service. General Terms of Service

Our firm would serve the City at the following *blended* hourly rates: Shareholders \$155.00 and Associates at \$145.00. Unless directed otherwise, we would bill all services on a monthly basis for the previous month's activities. Each billing will identify the attorney performing the work, the matter on which the attorney worked, a description of the work performed, and the time spent on the task. The time of legal services will be billed in increments of 1/10 (0.1) of an hour (6 minutes.) For example, if 18 minutes are spent preparing a brief letter, the charge will be 3/10 (0.3) of an hour.

It is our practice to provide our clients with a <u>detailed</u> description of our billing entries. This will enable the City Administration to clearly and easily identify the project that each entry relates to and exactly what work was done on that project in the amount of time identified. We believe that you should not have to guess at what services were rendered on your behalf or spend time finding out. Although we find that this practice virtually eliminates billing questions and issues, we always welcome the opportunity to discuss and address any concerns should they arise.
