# To ease the in-person registration process:

- All registration forms must be completed ahead of time one form per person.
- Only (1) representative per room is required to be present to register for the trip. This designated representative person does NOT have to be going on the trip. This will allow for participants who are unable to make the registration date secure their room.
- Room representatives are only allowed to secure (1) room and may not register for multiple rooms.
- In-person payment: cash, money order, check, or credit/debit card (a \$2.50 fee will be charged per credit/debit card transaction).
